- 1. Document Download & Submission:** Tender documents may be downloaded from Central Public Procurement (CPP) Portal <https://eprocure.gov.in/eprocure/app>. Bids shall be submitted online only at CPP Portal. Bids sent by FAX, email or offline mode will not be considered. No correspondence will be entertained in this matter. Not more than one bid against this tender shall be submitted by a bidder.

- 3.** The prices should be quoted only in INR, detailed price strictly as per enclosed BOQ in tender document Section 5 and total price as per price bid format of BoQ in .xls
- 4.** Bidder, who has downloaded the tender from CPP Portal shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found

to be tempered /modified in any manner, bid will be completely rejected and bidder is liable to be banned from doing business with C-DOT.

5. **Submission of Bids:** The tender shall be submitted online in Two part, viz. technical bid, and financial bid.
 - a. List of documents to be uploaded under technical bid cover as mentioned in the tender document.
6. The Financial bid should be strictly as:
 - a. Detailed price strictly in as per enclosed BoQ and
 - b. Total price as per price bid format of BoQ in .xls
7. Bids will be opened as per date/time as mentioned in the Tender Critical Date Sheet. After online opening of Technical-Bid the results of their qualification as well Price-Bid opening will be intimated later.
8. Intending bidders are advised to visit CPP Portal regularly till closing date of submission of tender for any corrigendum/addendum/ amendment.
